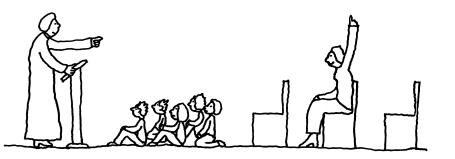

Being a treasurer



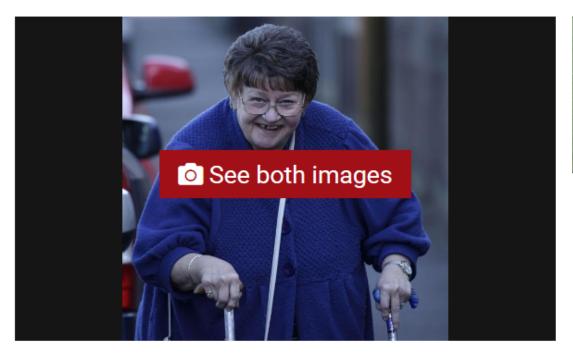
- Honesty and integrity

Finance and Resources: Mission not Maintenance

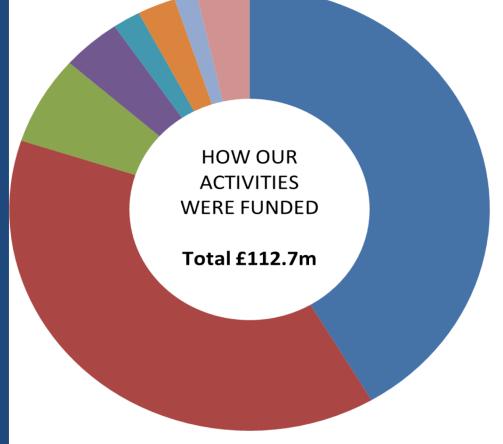
- Devolve resources and staff to presbyteries to help free up local congregations for missional activities
- Could some central functions be outsourced?
- Review Mission and Ministries payments, described by one person as a "tax on growth"
- Site teams in presbyteries to handle administrative tasks

Finance and Resources: Mission not Maintenance

- Use resources to nurture areas of growth not to maintain outworn structures
- Unite churches and sell off extra buildings to focus on mission "Get rid of church halls" "Give every congregation an outreach budget"
- Release money from rich fabric funds to fund outreach workers

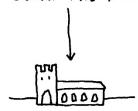

National Stewardship Programme

It was expected that the programme would be: a.able to increase giving throughout the church **b.adaptable** to congregations of all sizes, locations and backgrounds c.susceptible to Presbytery oversight d.capable of running without a significant increase in staff costs e.adaptable for use at the right time in the life cycle of the congregation

Congregations are expected to take action every year with a focus on money at least every third year.

External Funding

Grants from External Funders

To help you find funding for your large project, the Stewardship team uses GRANTfinder to plough through the 1,000s of possible grants or trusts and identify the ones that could potentially support your project.

Key steps:

- 1. We ask you to complete a simple pre-search form
- 2. We then run a search and provide you with a list of potential funders including their contact details where you can obtain application forms, closing dates and useful information to include in your application



3. Your congregation can then apply and await their decision.

Online Fundraiser - Give.net

- 100% not-for-profit Give.net is a part of Stewardship, a Christian charity. There are no profits at the end of the year
- Give.net reclaim your Gift Aid Give.net claim Gift Aid automatically, on a weekly basis, which ensures that reclaimed tax reaches your church as soon as possible (usually between six to eight weeks)
- Easy to use reporting Stay up to date with how much you've raised and how successful your fundraising has been. Easily accessed reports allow you to keep track of how much you have raised online. View them online and download to Excel or other software to help with your accounting, or in order to create mailings to supporters

Give.net – the numbers

- A donor's gift £10.00
- Gift aid £2.50
- Admin £0.38
- Card processing £0.00
- Your charity receives £12.12
- Fees Just 3% of donations. No set up fee.
 No monthly fees and no hidden charges.

Text Giving

- JustGiving offer a free service called JustTextGiving which enables registered charities to receive donations made through mobile phones. This is currently only open to registered charities.
- If you are a registered charity and would like to try this out, all you needs to do is visit the <u>JustGiving website</u>.
- There are no charges for either the church or for the donor for this service.

Ministry and Mission Allocations

- Proposed allocations were sent from the Stewardship & Finance
 Department in Edinburgh in August 2018.
- The figures are based on a three year average income and this information is taken from the congregational accounts and information provided each year.

For 2019

- Presbytery has powers to increase or decrease the proposed figures.
- In 2018/9 it has a 5% allocation from which to reduce the total amount to be sent from our Presbytery.

Gordon Presbytery has previously agreed that congregations can seek a reduction in their Ministry and Mission Allocation for one of four reasons:

- 1) The congregation is engaged in an imaginative local mission project, which required considerable expenditure on the congregation's part.
- 2) The congregation is facing considerable expenditure on a major repair to one of its buildings.

Cont'd

- 3) To write off shortfalls from previous years where Presbytery considers this course of action to be appropriate.
- 4) To reduce actual allocations during the year to which they apply if extraordinary changes in circumstances arise which would justify this course of action.

Ministry and Mission Allocations

- A revised schedule of M&M allocations was agreed by Presbytery at its November meeting and returned to Edinburgh to meet the 15th November deadline.
- Changes in M&M allocations can be made throughout the year with the closing date for changes being the 30th September.
 Deadline is usually in August.

Data developments

Attestation of Accounts

- Signed accounts are to be submitted to the Finance Committee by the April Presbytery meeting (April 2019)
- If they are going to be late, it is helpful to let the convenor know.
- A copy should also be sent to '121' for their information.
- The committee uses the checklist provided to attest the accounts.

Attestation of Accounts

- Report is provided during the June meeting of Presbytery of progress and an interim report is submitted to '121'
- Any issues which need to be resolved are addressed prior to a final report submitted by the end of September.

Every Financial Board shall prepare and approve an annual Budget of estimated General Fund Income and Expenditure.

Every Financial Board shall provide its members annually with a copy of the Budget. In addition, copies of the Budget shall be made available, for information, at the Stated Annual Meeting or equivalent **Congregational Meeting at which the** annual Accounts of the congregation are received.
